

Patient Eligibility

Anyone who has trouble hearing on the phone is a good candidate for CaptionCall. There is no predetermined decibel threshold to qualify. Your patients must simply have a hearing loss that, in your professional opinion, necessitates the use of captioned telephone service to communicate effectively by phone.

How Can CaptionCall Be Free?

CaptionCall is funded by a federal program as a provision of the Americans with Disabilities Act, giving individuals with hearing loss access to captioned telephone service at no cost. CaptionCall is an FCC-authorized captioned telephone service provider and is compensated by the federal government for providing this service. The CaptionCall phone is not covered by the federal fund but is offered by CaptionCall at no cost to eligible individuals. There is literally no cost to participate in this program when certification of hearing loss from a hearing-care or healthcare professional is provided.
